

# **Rule Listing Awards**

## **Section 1 - Introduction**

(1) The awards referred to in these Rules may be conferred on or awarded to candidates who have satisfied the provisions of the Rules, Requirements or Schedules governing the particular award.

(2) The Council, of its own motion or on the recommendation of the Academic Senate may make awards ad eundem gradum or honoris causa to persons who, in the opinion of the Council are eligible for or might properly be honoured by those awards. This policy should be read in conjunction with the Rules Governing Honorary Awards and Exceptional Service Medals.

# Section 2 - Scope

(3) The awards listed in Sections 4 to 10 of this Rule have been approved by Council. They are awards that may be or have been awarded by the University.

# Section 3 - Display of Abbreviated Qualifications

(4) It is recommended that staff and alumni observe the following conventions and protocols when displaying abbreviated qualifications.

- a. List National Honours before all other qualifications.
   For example: AM, BEnvSc(Newcastle)
- b. List the name of the awarding institution in parentheses and italics.
   For example: BSPath(Newcastle)
- c. Do not use a space or comma between the name of the degree and the awarding institution.
   For example: Degree + Institution = BEd(Newcastle)
- d. Clearly identify when a degree is an honorary award.
   For example: Hon DEd(Newcastle)
- e. Place professional qualifications after academic qualifications. For example: BBus(Newcastle), MAICD
- f. Use a comma after each consecutive degree at the same institution. For example: BA, MBA(Newcastle)
- g. List lowest to highest qualification with awards from the same institution grouped together. For example: BA, PhD(OtherInstitAbbrev), BdevStud, GCertEM(Newcastle)
- h. Do not use a space between the final degree and the institution.
   For example: BMed(Newcastle)
  - i. BA(Hons), PhD(OtherInstitAbbrev), BSc(Hons)(Newcastle)
- i. List only the Masters degree if both Bachelors and Masters degrees have been awarded in the same area of study and from the same institution. List both if awarded by different institutions.
   For example:- BA(Newcastle) + MA(Newcastle) = MA(Newcastle)

- i. BA(OtherInstitAbbrev) + MA(Newcastle) = BA(OtherInstitAbbrev), MA(Newcastle)
- $j. \ \mbox{Do not leave any space between the name of the degree and honours.}$

For example: Degree + Honours = BCompSc(Hons)

k. Use the abbreviations for award and institution name that are preferred by the granting university.

(5) The approved abbreviations for awards from the University of Newcastle are provided by this rule.

(6) The appendices of the Commonwealth Universities Year Book provide a useful guide for abbreviations of other Universities within the Commonwealth.
